WHEREAS...

- (a) Nullifying *LCR230706-ABOR.A* - trash compartment regulation.
- (b) Nullifying *LCR230708-ABOR.A* - Electronic LED off regulation.
- (c) Amending *LCR230708-ABOR.B* - to allow only for special occasions.
- (d) Nullifying *LCR230907-ABOR.A* - food and soft drinks near the bed regulation.
- (e) Amending *LCR25523.FSOC.A* - to allow up to 15% in tip for select restaurants, and allowing 10% for all other establishments, removing the requirement to leave no tip at all provision.
- (f) Nullifying *LCR25501-FSOC.A* - financial regulation that requires fund establishment, and will be replaced by a future financial regulation.
- (g) Creating a new financial regulation that requires all transactions in excess of \$75 to go through a mandatory docket review process.
- (h) Amending *LCR240911.DHHS.A525* - to require a provision to refrain from and remove individuals who consume alcohol frequently who are not designated by the Ministry of Foreign Affairs as "Person of Significant Interest", similar to *LCR230228.DHHS.A525*.

OPINION

It is necessary to remove obsolete regulations and update regulations to better conform to our personal views.

THEREFORE...

Effective **February 19th, 2026**, the following regulations are hereby nullified and void:

- *LCR230706-ABOR.A*
- *LCR230708-ABOR.A*
- *LCR230907-ABOR.A*
- *LCR25501-FSOC.A*

Effective **February 19th, 2026**, the following regulations are hereby amended as follows:

- *LCR230708-ABOR.B* - rewriting the regulation from: "Soft Drink Restriction – You can only drink soft drinks (Sugary beverages) up to once per month." To: "Effective: 02/19/2026 Restricted Sugary Beverages - Sugary beverages as defined by the Department of Health and Wellness shall be permitted for consumption only for special occasions. Special Occasions, for the purpose of this regulation, means a designated occasion that occurs infrequently or no more than once every two weeks."
- *LCR25523.FSOC.A* - rewriting the regulation from: "Effective: 05/29/2025, It shall be prohibited to pay more than 10% in tips of the sale price. Furthermore, if the no tax on tips legislation becomes law, it shall be prohibited to leave any tip at all." To: "Effective: 02/19/2026, standard tipping practice shall be to pay only 10% of the sale price. Exemption: Establishments approved by the Financial Services Oversight Committee for exemplary service or quality may be allowed up to 15% in tips of the sale price."



- *LCR240911.DHHS.A525 - rewriting the regulation from: "Effective: 06/30/2025, WHEREAS issuing revised guidance on our official stance on alcohol consumption. Revised 05/05/2025, OPINION: I strongly dislike the taste of alcohol and don't really see a need to push for allowing myself to drink. Nevertheless, it shall be allowed in limited safe situations. THEREFORE, effective 06/30/2025, our official policy stance on the consumption of alcohol shall be to allow in a limited capacity. Permitting the conditions set forth, Consumption will only be allowed for special occasions that are made known in advance. "Known in advance" for the purpose of this regulation means being made known in writing for at least two days before the special occasion. "Special Occasion" for the purpose of this regulation means a designated occasion that occurs infrequently or no more than once every two weeks." To: "Effective: 02/19/2026, WHEREAS issuing revised guidance on our official stance on alcohol consumption. Revised 01/19/2026, OPINION: We strongly dislike the taste of alcohol and don't really see a need to push for allowing consumption. Nevertheless, it shall be allowed in a limited capacity. THEREFORE, effective 02/19/2026, our official policy stance on the consumption of alcohol shall be to allow in a limited capacity. Permitting the conditions set forth, Consumption will only be allowed for special occasions that are made known in advance. "Known in advance" for the purpose of this regulation means being made known in writing, text, or through other verifiable methods at least two days before the designated special occasion. "Special Occasion" for the purpose of this regulation means a designated occasion of significant value that occurs infrequently, infrequently being no more than once every two weeks. Furthermore, individuals who are not designated "Significant Interest" by the Ministry of Foreign Affairs who regularly consume high volumes of alcohol shall be removed from our lives and require distancing ourselves from said individuals pursuant to LCR230812-SEWFA.A, subsection (c),(g), and (h)."*

Effective **February 2nd, 2026**, the following regulation is hereby ordered:

- *"LCR26119.FSOC.A - Financial Docket Reporting and Review - Effective: 02/02/2026, any purchase in excess of \$75 shall be required to be submitted through a docket request form, also known as the FSOC-F22 form, requiring approval from the Financial Services Oversight Committee (FSOC) before funds are allowed. Exemption: Grocery, Restaurant, or Gas purchases shall be exempt."*
